



Contribution to Australian Employment

The value that small business contributes to employment numbers in Australia is one indication of their contribution to the Australian economy. This can be measured by comparing the number of employees working in small business with employees in other business sizes and similar break downs within industries.

1. Contribution to Australian employment



Small businesses (as defined by the ABS as those employing 0-19 employees) employed over 5 million people, which is 42% of the private sector workforce¹ in 2020-21 as shown in Table 1.

Chart 1: Employment by business size





Chart 1 shows how the pattern of employment has changed very little over the past three years.

Chart 2 shows the industry sectors where small businesses make the greatest contribution to employment. The top three industry sectors are:

- Construction (employing 793,000 people in June 2021)
- Professional, scientific and technical services (employing 571,000 people in June 2021)
- Accommodation and food services (employing 508,000 people in June 2021).

Notably in table 2, the private sector industries most reliant on small business for employment (that is, with two thirds or more of people employed by small businesses) were:

- Agriculture, forestry and fishing (82% of employment by small businesses)
- Rental, hiring and real estate services (75% of employment by small businesses)
- Construction (66% of employment by small businesses)
- Other Services (66% of employment by small businesses).
