



Australia's Small Businesses by Regional and Metropolitan Areas


This data presents small businesses in Australia according to their regional or metropolitan area classification, focusing on numbers, location and size.

Please note that for this data the Australian Small Business and Family Enterprise Ombudsman (ASBFEO) defines small businesses as those with less than 20 employees. The data is classified using the Australian Statistical Geography Standard (ASGS).

Key findings

- Of the 2.3 million small businesses in Australia, 69% (1.6 million) were located in a greater capital city area and 31% in a regional area.
- Queensland and Tasmania had the greatest proportions of small businesses located in regional areas.
- The number of small businesses increased in all states and territories in the year to 30 June 2021. These rises were spread across capital city and regional areas.

Excludes businesses not registered for GST. "Other" is comprised of a small number of businesses where information is only available at the state/territory level.



Of the 2.3 million small businesses in Australia, 1.6 million (69%) are located in the greater capital city areas and 31% (716,609) in regional areas on 30 June 2021. This closely reflects the split of the Australian population, with $67\%^1$ of all Australians living in the greater capital city areas.

As shown in the chart above, Queensland and Tasmania were the only states with a higher proportion of small businesses in regional areas than capital cities on 30 June 2021.


As shown in the table above, 716,609 small businesses were in regional areas on 30 June 2021. Over one-third of these small businesses were in regional Queensland.


The composition of small businesses is similar in greater capital cities and regional areas. There was a shift from non-employing to employing businesses in both capital cities and regional areas in 2021.

This was partly due to the Australian Bureau of Statistics reclassifying businesses. The national data indicates that this shift reversed in 2022. Nationally, non-employing businesses increased by 10% in the year to June 2022. Increases in the number of small businesses have historically been higher in metro areas when compared to the regional areas. However, there was strong increase (4%) in the number of small businesses in both greater capital city and regional areas in the year to June 2021.
